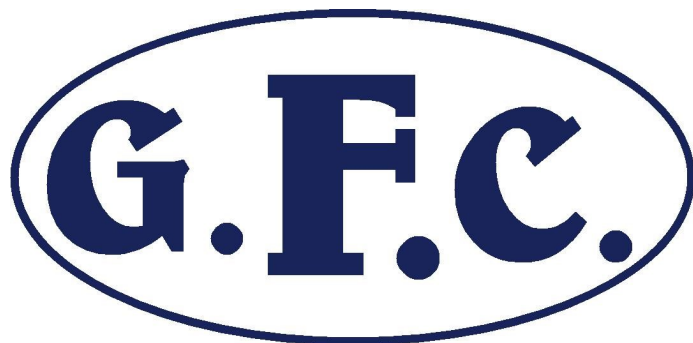

### SPRAY RECOMMENDATIONS

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions. When applying by air, use a nonionic surfactant for improved coverage.
