DIRECTIONS FOR USE

Citrus and Fruit Crops: 2-4 quarts per acre in enough water to cover as needed, 1-2 quarts per acre in at least 5 gallons of water by air

Vegetables & Row Crops: 1-2 pints per acre in enough water to cover

Ornamentals & Trees: Dilute 1 to 2 quarts per 100 gallons of water and spray foliage to runoff. Apply as needed.

SPRAY RECOMMENDATIONS

G.F.C. Azutech MZF can be added to most nitrogen solutions, fluid fertilizers, can be tank mixed with most pesticides and is recommended for use throughout the season in a program of multiple applications. Always perform a jar test for unfamiliar spray combinations. Do not use in high phosphate starter fertilizer materials. The addition of urea nitrogen or a non-ionic surfactant will aid in uptake.
